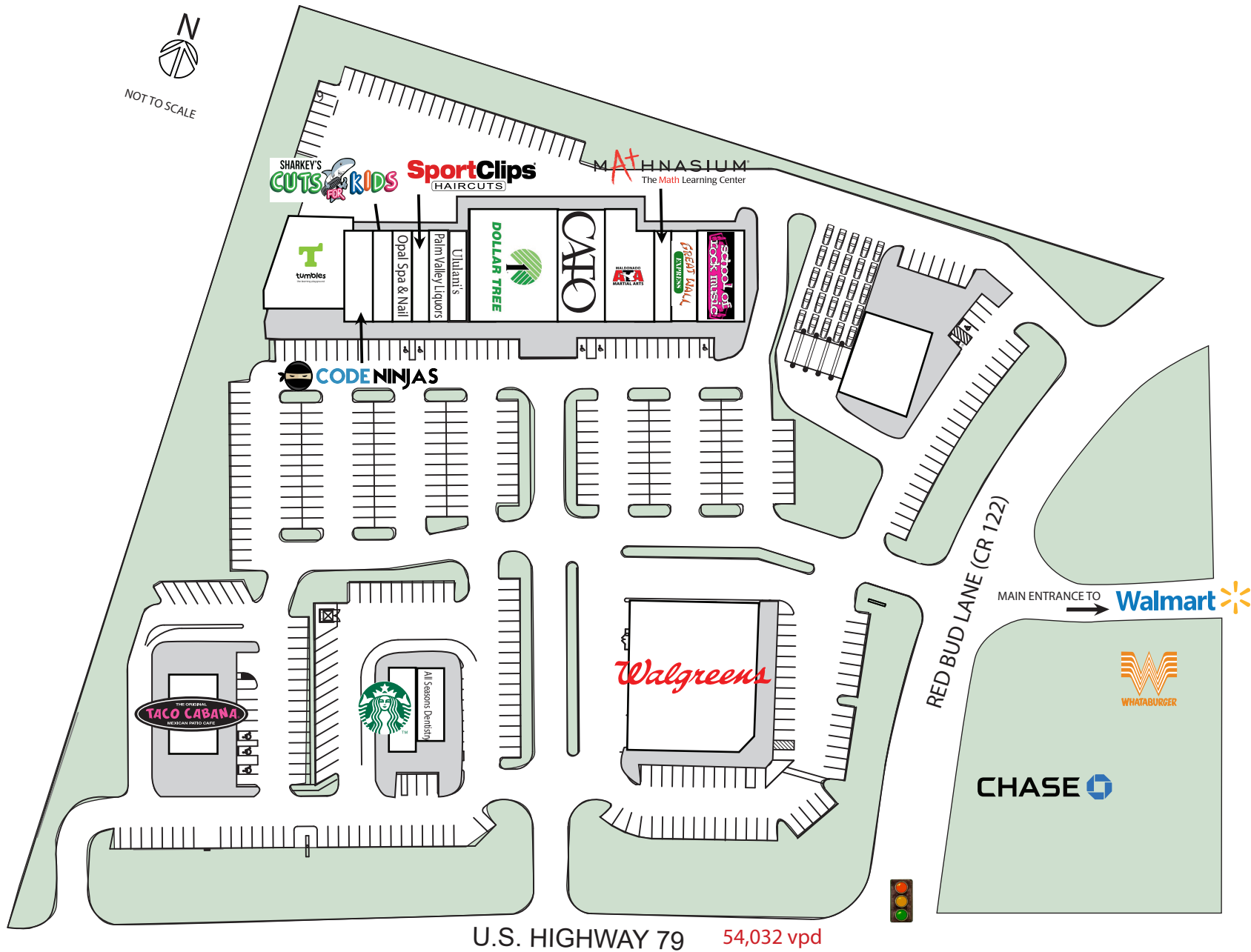

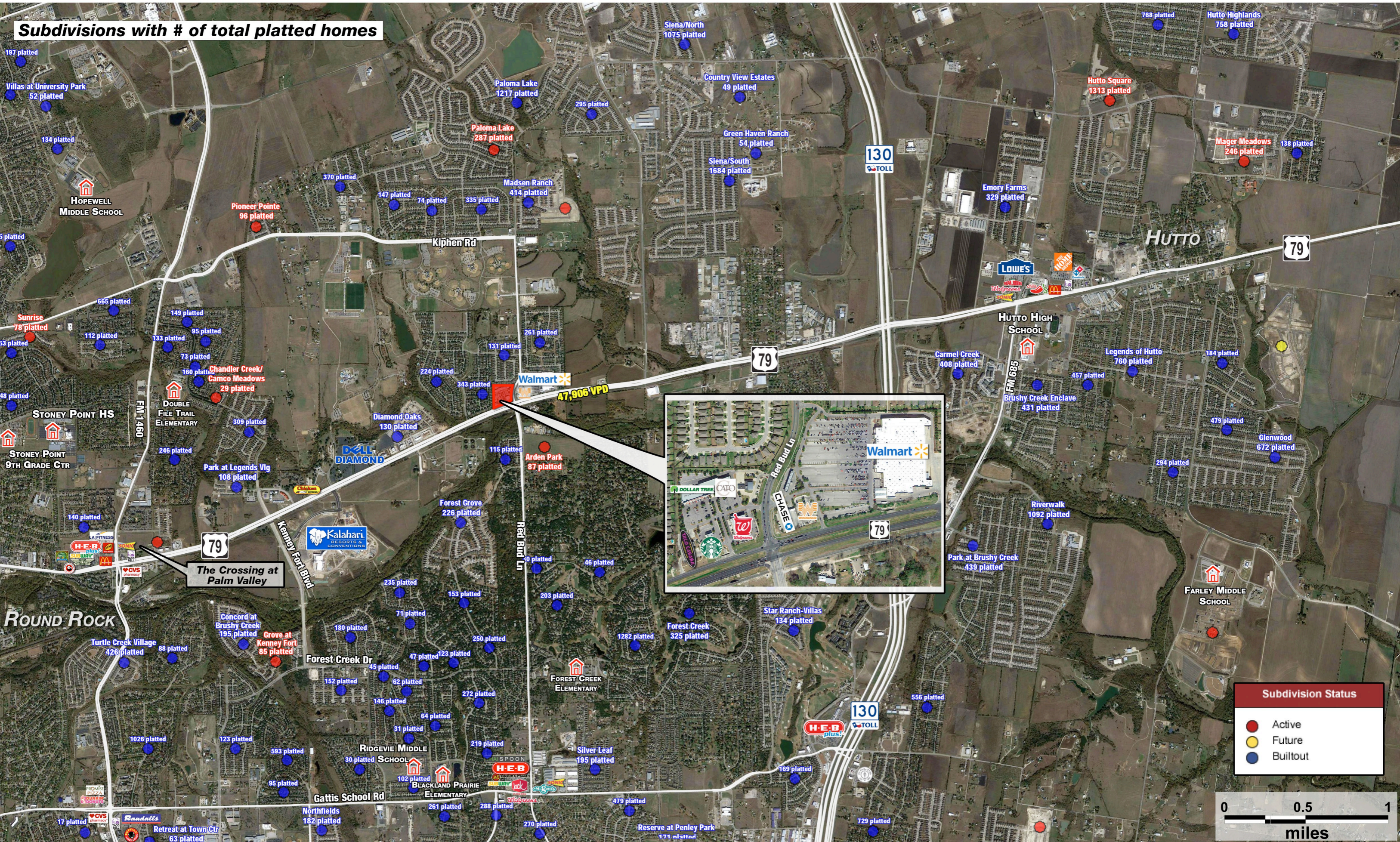


PALM VALLEY PLAZA | NWC OF HWY 79 & RED BUD LN, ROUND ROCK, TX 78665
